Permission to land on any landing strip at Nyathi is conditional upon the following:

1. Acceptance of the disclaimer/waiver below.
2. The pilot/operator shall before departure to Nyathi ensure that all passengers and occupants of the aircraft are made aware of this disclaimer/waiver.
3. The pilot/operator shall before departure to Nyathi fax or email this form and the signed Nyathi waiver and indemnity form to Hubi von Moltke at 011 908 5439 or hvm@cheetahtech.co.za, alternatively contact Hubi on 083 676 5471. 4. The pilot/operator has read and understands the attached basic rules and guidelines to the airfield.

Permission to land on Nyathi is conditional upon compliance with these terms. Failure on the part of the pilot/operator to comply strictly with the requirements listed above shall automatically render any permission to land granted under this request null and void.

DISCLAIMER/WAIVER

I/We(name of pilot/operator and hereafter referred to as the User) acknowledges that the landing strip at Nyathi is unlicensed and closed for all air traffic that has not been given written consent to land or take off at Nyathi by the Nyathi HOA (NHOA). The User hereby indemnifies and holds harmless the NHOA, it's Trustees, employees, agents, members and servants, from all claims that the User or any of its passengers and/or occupants (of the aircraft) may have arising out of any injury (including injury resulting in death) or loss however caused (including gross negligence) sustained by them, arising from the use of the landing strip. The User further indemnifies and holds harmless the Trustees of NHOA and any of the employees, agents, members and servants of the NHOA, against all liability to any of the User's employees, agents and servants and any of its passengers or occupants (of the aircraft), in consequence of the use by the User of the landing strip. The User's employees, agents and servants and any of its passengers or occupants (of the aircraft), shall have no claim for damages of whatsoever nature against the Trustees of NHOA and any employees, agents, members and servants of NHOA, arising from any loss or injury suffered by it and its passengers or occupants (or the aircraft), however caused and notwithstanding that such loss is attributed to any negligence (including gross negligence) on the part of NHOA, its Trustees, employees, agents, members and servants.
